In this role, you will support the Division's Investment Operations and Finance department, specifically the Middle Office and Treasury Operations and Investment Accounting teams.

As the ideal candidate, you are a strong team player with excellent communication skills, strong problemsolving and analytical skills, and attention to detail. You are organized, self-motivated, and flexible. You are able to meet deadlines and you have an excellent work ethic.

Primary Responsibilities - Middle Office and Treasury Operations

- Provide trade support for all trading activities, including derivatives, using Bloomberg Order Management System
- Conduct reconciliations and provide treasury support for the cash movements and wire payments across the administrative and investment activities
- Support the collateral and exposure management processes across counterparties
- Collaborate with internal teams on trade capture and contribute to various initiatives as needed

Primary Responsibilities - Investment Accounting

- Conduct reconciliations and validations for investment-related activities (positions held, cost, market value, and investment income) and identify discrepancies between the accounting book of records (ABOR) and the custody records
- Ensure accounting, tracking, and reporting of all life cycle events relating to corporate actions
- Follow up on all outstanding global issues and ensure all dividend rates, reclaims, and withholding taxes reflect the latest updates from global issues reports as per our custodian
